CONVENIENT DRAFT PAYMENT PLAN APPLICATION

The "Convenient Draft Payment Plan" was developed to provide an easier more convenient method for persons to obtain permits for residential and approved commercial projects.

The process is simple. You fill out the applications on the reverse side of this sheet (upper and lower portions) and return them to our office. You arrange to have your draft forms printed. Note that the draft forms (see example attached to this sheet) must be printed, bound as are personal checkbooks, and the duplicate check method must be used. The draft forms must be delivered to our office and you are ready to begin using the draft payment process.

When using the draft payment process, you may fax, mail or hand deliver the permit application to our office. In the case of a fax, the permit will be written and faxed back to you. In the case of a mailed in permit application, your permit will be mailed back to you. When the permit application is hand delivered, you may pick up the permit, or have it faxed or mailed to you. Note that the job for which a permit is being obtained is not permitted until you receive a permit, therefore the work should not begin until you receive your permit.

You may also pay other fees via the draft payment plan, such as plan review fees, license fees, etc. No draft will be processed which is not authorized by you or your authorized agent.
